- Information about Brazilian importers and distributors of the product
- · Information regarding tariff and regulation applied to the product for Brazilian imports
- Business flow for import process in Brazil
- Relevant sector associations and organizations regarding the product
- Overview of Brazilian tax structure applied to imported goods

### C. Submission of Quotation

 Quotation should be sent to the following address in a sealed cover:-

# D. Details of Quotation:

- The proposal may mention details of the services being provided and head-wise costs of each service and the total cost. All amounts may be mentioned in Brazilian Reais and one final amount should be proposed including all taxes and without any condition of subsequent variation of exchange rate.
- The payment finally agreed will be released in two instalments by the Consulate – first instalment within one week after approval of quotation and second instalment within one week of the submission of the market survey report (after receipt of payment voucher from the company).
